Subject: Building activities around Strawinskyhuis

Dear resident, business owner or other interested party,

The renovation of Strawinskyhuis on 39-43 Prinses Irenestraat is now complete. Law firm DLA Piper moved into the building on 8 January 2024. The public space around the building is not finished yet, it will be restored by contractor Huybens Haarlem between 15 January and 8 March 2024. This means that the construction site will be dismantled, and that the space around the building will be cleaned up and made accessible again. From 8 March, Strawinskypad can also be used again. In this letter, we would like to inform you of the upcoming activities.

## **Public space**

Building activities have caused damage and subsidence to part of the paving around Strawinskyhuis. This public space is now being restored and repaved. Part of Amaliaplein on the side of Strawinskyhuis is also being restored. The new paving on the side of Prinses Irenestraat will be a temporary solution. At a later stage, the entire Prinses Irenestraat will be refurbished -, in line with the green lay-out applied to the area in front of the Goede Doelen Loterij building at the top of the street. More information about this refurbishment will be provided in the second half of this year.

## The work will be executed in three phases:

Phase 1: Monday 15 January to Friday 2 February 2024

During this phase, the focus will be on the public space to the north of Strawinskyhuis (on the side of Prinses Irenestraat). During these activities, Prinses Irenestraat will be narrowed down to a width of 5 metres (at a minimum). Cars and bicycles will be able to pass by the building site. Pedestrians will use the footpath on the opposite side of the street. At the start of this phase, a so-called sump well will be removed from the Prinses Irenestraat side. This work will be audible in the immediate vicinity. The contractor will do their utmost to limit noise pollution to a minimum, but will unfortunately not be able to avoid it altogether.

Phase 2: Monday 5 February to Friday 16 February 2024

During this phase, the public space to the south of Strawinskyhuis (on the side of Strawinskypad) will be furnished. These activities will not result in any significant inconvenience to the surrounding area.

Phase 3: Monday 19 February to Friday 8 March 2024

During this phase, the public space to the west of Strawinskyhuis (on the side of Prinses Amaliaplein) will be taken care of. These activities will also be carried without causing any significant inconvenience to the surrounding area.

During the last week of the building works (from Monday 4 to Friday 8 March), all temporary fixtures, like site fencing, steel road plates and the construction road from Strawinskylaan to Strawinskypad, will be dismantled. Strawinskypad will then be re-opened to cyclists and pedestrians.
